



MasterCard Contactless – TfL – Fare Free Friday Full Terms & Conditions

1. This offer is open to MasterCard Contactless card and device holders.
2. Offer only valid if using a MasterCard Contactless enabled card or device.
3. The offer will be available from **04:30am 14/11/2014** to **01:00am 15/11/2014** inclusive ("Promotional Period").
4. To redeem the offer, MasterCard Contactless card and device holders must use their MasterCard Contactless card or device to travel on the London Underground, London Buses, London Overground, Docklands Light Railway, participating National Rail services in London and the Tramlink during the Promotional Period.
5. The offer entitles MasterCard Contactless card and device holders to receive a refund against their travel costs, made with a MasterCard Contactless card or device, on the London Underground, London Buses, London Overground, Docklands Light Railway, participating National Rail services in London and the Tramlink during the Promotional Period, to a maximum value of £21.80. The offer is as stated and nothing else is included.
6. The refund will take up to 28 working days from the end of the Promotional Period to appear in the MasterCard Contactless card and device holder's account.
7. All qualifying journeys must be paid for using a MasterCard Contactless card or device.
